- ✓ Be a registered voter of the City
- ✓ Shall not be delinquent in the payment of any monies owed to the city (city taxes, city utilities, or other assessments)
- ✓ Shall not have any pending claims against the City
- ✓ Shall not be related to any city council member (defined under Article X, Section 34 of City Charter)
- ✓ Shall have no conflict of interest (business) and/or appearance of impropriety where the position could result in personal advantage or monetary benefit
- ✓ Shall not have been convicted of a felony or crime involving moral turpitude (or offense as a class B misdemeanor or higher for consideration of appointment to Ethics Review Board)
- ✓ Have a demonstrated record of attendance and participating performance.
- ✓ Maintain an open mind to all issues under consideration.
- ✓ Have the ability to listen, learn and discuss issues.
- ✓ Have the ability to make decisions based on information gathered and discussed and for the betterment of the city as seen through the City's Unified Development Code and Comprehensive Plan.
- ✓ Have the ability to see and understand the city long-term objectives and short-term benefits.
